

CONTEST RULES

- A. **THESE CONTEST RULES (“CONTEST RULES”) SET THE TERMS AND CONDITIONS FOR THE CONTEST “WIN A GOPRO” (“CONTEST”) FOR PLAYERS OF THE ONLINE GAME “WORLD OF WARSHIPS”.**
- B. **NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS CONTEST. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**
- C. **THIS CONTEST IS OPEN TO INDIVIDUALS WHO ARE OF AGE OF MAJORITY UNDER THE LAW OF THEIR STATE OF RESIDENCE. INDIVIDUALS WHO ARE UNDER THIS AGE MAY PARTICIPATE ONLY IF THEIR PARENTS OR GUARDIANS CONSENT TO THEIR PARTICIPATION IN THE CONTEST.**

GENERAL RULES

1. **Sponsor**

This Contest is organized by Wargaming Group Limited (the “**Sponsor**”), registered at 105 Agion Omologiton Avenue, Nicosia 1080, Cyprus.

2. **Eligibility**

- (a) Participation in this Contest is open only to individuals who enter in accordance with these Contest Rules. ONLY individuals residing in the countries of the European Union or the United States are eligible to win the prizes.
- (b) Each Contest participant (“**Participant**”) is responsible for providing accurate information as to his/her name, age, email or physical address, if such information is requested. Individuals that provide incomplete or false information are ineligible to participate.

3. **Prize Substitution**

Sponsor reserves the right to substitute the prize or any part thereof with a prize of equal or greater value in its sole discretion. The Participant is not entitled to receive a cash substitution of the prize.

4. **Grant of Rights by Participants**

By accepting these Contest Rules, each Participant grants Sponsor and its licensees the right to use the Participant’s name, image, likeness, and/or prize information, and/or any portion of any of the foregoing, for promotional, advertising and/or publicity purposes with respect to the Contest in any media, throughout the world and in perpetuity, without compensation or notice to, or with further consent of, the Participant.

5. **Waiver and Release of Liability by Participant**

- (a) The liability of the Sponsor is unlimited for damages arising out of death, body injury or health damage based as well as for damages that arose in case of fraudulent intent.
- (b) The liability of the Sponsor is unlimited for damages caused by the Sponsor by intent or gross negligence.
- (c) In other cases, except under clause 5 (a), 5 (b) and 5 (d), Sponsor will only be liable to the amount of the typically foreseeable damage.
- (d) Liability stipulated by applicable law remains unaffected.

- (e) The limitation period for claims for damages shall be one (1) year, except in case of clause 5 (a), 5 (b) and 5 (d) where the statutory statute of limitations shall apply.

6. **Tampering**

- (a) Sponsor reserves the right to disqualify and prohibit from participating any person, who is or is attempting to: (i) tamper with Sponsor's website and/or any part of the Contest; (ii) attempting to undermine the legitimate operation of the Contest by cheating, deception, or other unfair playing practices, (iii) intending to annoy, abuse, threaten or harass any other Participants; and/or (iv) otherwise violating these Contest Rules or the World of Warships End User License Agreement (EULA), if applicable.
- (b) ANY ATTEMPT TO DAMAGE SPONSOR'S WEBSITE OR GAMES OR UNDERMINE THE OPERATION OF THIS CONTEST MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS. SHOULD ANY SUCH ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES AND ANY OTHER AVAILABLE REMEDIES FROM ANY PERSON RESPONSIBLE FOR SUCH ATTEMPT TO THE FULLEST EXTENT PERMITTED BY LAW.

7. **Sponsor's Right to Terminate this Contest**

If there is evidence of fraud, tampering or unauthorized intervention with any portion of this Contest, or if technical difficulties of any sort (e.g., computer viruses, bugs, server errors) compromise the integrity of the Contest, the Sponsor reserves the right to terminate the Contest and not to award the prize.

8. **General Terms**

- (a) This Contest is governed by the laws of the Republic of Cyprus. The provisions of these Contest Rules do not exclude, limit or otherwise restrict the rights vested with the consumers upon relevant provisions of the applicable law nor may be construed in this way. By entering, each Participant agrees to comply with these Contest Rules and the World of Warships EULA.
- (b) In order to validly enter and in order to claim the Prize, Participants may be required to provide Sponsor with certain personally identifiable information such as name, residential address, email address and/or other contact and/or tax information. Such information may be used for the purposes specifically described in these Contest Rules.
- (c) The invalidity or unenforceability of any provision of these Contest Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Contest Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
- (d) All taxes, fees and surcharges on the prize are the sole responsibility of the prize winner. In the event that the selected winner of the prize is ineligible or refuses the prize, the prize will be forfeited and Sponsor, in its sole discretion, may choose whether to award the prize to another Participant in the Contest.

SPECIFIC RULES

1. Nature of the Contest

To become a Contest Participant, a user needs to do all of the following during the Contest Period.

1. Press the “Participate” button in the World of Warships portal publication about the Contest that contains the link to these Rules (to proceed, the user will be asked to log in into their game account on eu.wargaming.net or na.wargaming.net or create a game account if the user does not have one).
2. Join [Captain’s Club](#). If the user is already a member of Captain's Club, the user can skip this step.
3. Play one battle in World of Warships.
4. Record and edit a World of Warships gameplay video lasting a maximum of 20 seconds.
5. Post the video on the [official World of Warships Facebook page](#) along with your World of Warships username and the server (EU or NA) that you play on.

2. Contest Period

The Contest Period starts on 18 December 2023 and ends on 1 January 2024 (00:01:00 UTC).

3. How winners are chosen

A jury composed of the World of Warships team members will judge the videos posted by Contest Participants and choose two winners on the EU server and one winner on the NA server, based on how action-packed, fun and well-edited the videos are.

4. Prizes

Each winner will receive a GoPro Hero12 Black Action Camera (approximate retail price – EUR 389,99).

5. How the Prizes are provided

The Sponsor will within thirty (30) calendar days of the end of the Contest contact the winners to request the information necessary to provide and deliver their prizes. The information requested will at least include name, delivery address and contact phone. The Participant shall have ten (10) calendar days to provide the requested information, otherwise the Prizes can be considered forfeited. The prizes will be sent to winners within thirty (30) days of the day when the requested information is provided in full. The actual delivery date may vary depending on the country of delivery.
