

# **“BLUE ARCHIVE PRIZE DRAW” EVENT RULES**

## **PREAMBLE**

- A. THESE EVENT RULES (“EVENT RULES”) ESTABLISH THE GENERAL TERMS AND CONDITIONS FOR “BLUE ARCHIVE PRIZE DRAW” EVENT (“EVENT”) FOR WORLD OF WARSHIPS PLAYERS. THE EVENT RULES CONSIST OF GENERAL EVENT RULES (PART A) AND SPECIFIC EVENT RULES (PART B).**
- B. THIS EVENT IS OPEN TO INDIVIDUALS WHO ARE OF AGE OF MAJORITY IN THE COUNTRY OF THEIR RESIDENCE. INDIVIDUALS WHO ARE UNDER THE AGE OF MAJORITY MAY PARTICIPATE ONLY IF THE PARENTS OR GUARDIANS OF THIS INDIVIDUAL CONSENT TO HIS/HER PARTICIPATION IN THE EVENT ON THE TERMS ESTABLISHED BY THESE RULES.**

## **GENERAL EVENT RULES**

### **Part A**

#### **1. Sponsor**

This Event is organized by Wargaming Group Limited, (the “**Sponsor**”), 105 Agion Omologiton Avenue Nicosia 1080 Cyprus.

#### **2. Eligibility**

- (a) Participation in this Event is open only to individuals who enter in accordance with these Event Rules. **Prizes in the form of Steam gift cards can only be won by individuals who reside in one of the following areas: Japan, Indonesia, Philippines, Taiwan, Singapore, United Kingdom, France, Austria, Latvia, Bulgaria, Lithuania, Croatia, Czechia, Netherlands, Denmark, Estonia, Finland, Romania, Slovakia, Slovenia, Spain, Hungary.**
- (b) Notwithstanding the foregoing, the following persons are NOT ELIGIBLE to participate in this Event: (i) employees of Sponsor who directly participate in the Event organization, its directors and agents (collectively – “**Involved Persons**”); (ii) parents, spouses, children, brothers and sisters of Involved Persons; and (iii) individuals living in the same household as Involved Persons.
- (c) Each participant is responsible for providing accurate information as to his/her name, age, and email or physical address (including the Place of Residence in the Account Management). Individuals that provide information that is incomplete, false or deceptive, will be ineligible to participate or (if they have already participated) to get a Prize in the Event.
- (d) If an individual is under the age of majority in his/her state of residence, this individual may participate in the Event only if the parents or guardians of this individual consent to his/her participation in the Event on the terms established by these Rules. The Sponsor can request written confirmation of such consent at any time. If such confirmation is not presented upon Sponsor’s request by the individual participating/wishing to participate in the Event, the Sponsor has the right to disqualify this individual.

#### **3. Claiming a Prize**

The Prize winners will receive an email from Sponsor. Regulations for granting the prizes are set out in the specific part of these Event Rules, Part B.

Sponsor reserves the right to substitute a Prize or any part thereof with a prize or element of equal or greater value in its sole discretion. If a Prize winner is not in compliance with these Event Rules, this Prize winner may be disqualified.

**4. Grant of Rights with respect to Participants**

By accepting these Event Rules, each participant grants Sponsor and its licensees the right to use the participant's name, image, likeness, photograph and/or Prize information, and/or any portion of any of the foregoing, for promotional, advertising and/or publicity purposes with respect to the Event in any media, throughout the world and in perpetuity, without compensation or notice to, or with further consent of, the participant.

**5. Waiver and Release of Liability by Participant**

- (a) The liability of the Sponsor and/or Sponsor Parties is unlimited for damages arising out of death, injury to body or health based as well as for damages that arouse from the lack of a guaranteed characteristic or in case of fraudulent intent.
- (b) The liability of Sponsor and/or Sponsor Parties is unlimited for damages caused by the Sponsor or Sponsor Parties by intent or gross negligence.
- (c) In case of a slight negligent breach of a contractual core duty Sponsor and/or Sponsor Parties shall, except in the cases pursuant to clause 5 (a) and 5 (d), only be liable to the amount of the typically foreseeable damage. Contractual core duties abstractly are such duties whose accomplishment enables proper fulfilment of the contract in the first place and whose fulfilment a contractual party regularly may rely on.
- (d) Liability stipulated by applicable law remains unaffected.
- (e) The limitation period for claims for damages shall be one (1) year, except in case of clause 5 (a), 5 (b) and 5 (d) where the statutory statute of limitations shall apply.

**6. Tampering**

- (a) Sponsor reserves the right to disqualify and prohibit from participating any person, who is or is attempting to: (i) tamper with Sponsor's website and/or any part of the Event; (ii) attempting to undermine the legitimate operation of the Event by cheating, deception, or other unfair playing practices, (iii) intending to annoy, abuse, threaten or harass any other participants, players, or Sponsor's parties; and/or (iv) creating self-made accounts (email or game accounts) when participating during referral campaigns in WG; and/or (v) otherwise violating these Event Rules or the [End User License Agreement](#) (EULA) of Sponsor, if applicable.
- (b) ANY ATTEMPT TO DELIBERATELY DAMAGE SPONSOR'S WEBSITE OR ANY OF SPONSOR'S GAMES (OR ANY PART OF EITHER) OR UNDERMINE THE OPERATION OF THIS EVENT MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS. SHOULD ANY SUCH ATTEMPT BE MADE, SPONSOR AND ITS LICENSEES (IF ANY) RESERVE THE RIGHT TO SEEK DAMAGES AND ANY OTHER AVAILABLE REMEDIES FROM ANY SUCH PERSON(S) RESPONSIBLE FOR ANY SUCH ATTEMPT TO THE FULLEST EXTENT PERMITTED BY LAW. EACH PARTICIPANT (OR, IF THE PARTICIPANT IS NOT OF AGE OF MAJORITY IN HIS/HER STATE OF RESIDENCE, THE LEGAL GUARDIANS THEREOF) AGREES TO INDEMNIFY AND HOLD HARMLESS SPONSOR, SPONSOR PARTIES AND AFFILIATES FROM AND AGAINST ANY AND ALL CLAIMS, LOSSES, DAMAGES AND/OR LIABILITIES (INCLUDING REASONABLE ATTORNEYS' FEES AND EXPENSES) THAT MAY BE ASSERTED AGAINST OR INCURRED BY ANY OF THEM AT ANY TIME, IN CONNECTION WITH

PARTICIPANT'S ENTRY MATERIALS, OR THE USE THEREOF, AND/OR BY PARTICIPANT'S BREACHES OF ANY REPRESENTATION, WARRANTY OR COVENANTS ASSOCIATED WITH THIS EVENT.

**7. Sponsor's Right to Terminate this Event**

If there is any actual evidence of fraud, electronic or non-electronic tampering or unauthorized intervention with any portion of this Event, or if fraud or technical difficulties of any sort (e.g., computer viruses, bugs, server errors) compromise the integrity of the Event, the Sponsor reserves the right to terminate the Event and award the Prizes based on the participant's results as of the moment of termination. The use of any automated launching or entry software or any other mechanical or electronic means that permits the participant to automatically enter or participate repeatedly is prohibited. In the event of a dispute as to the identity of a participant based on an email address, the participant may be disqualified.

**8. General Terms**

- (a) This Event is subject to these Event Rules and is governed by the laws of the Republic of Cyprus. To the extent that the law of the Republic of Cyprus deprives the participant of the protection afforded to him/her by provisions that cannot be derogated by virtue of the law of the area where the participant has his/her habitual residence, the law of that area applies. The provisions of these Event Rules do not exclude, limit or otherwise restrict the rights vested with the consumers upon relevant provisions of the applicable law nor may be construed by anyone in this way. By entering, each participant agrees (or if under the age of majority in his/her state of residence – his/her parent and/or legal guardian agrees) to comply with these Event Rules and the [EULA](#) of Sponsor.
- (b) In order to validly enter and in order to claim the Prize, participants may be required to provide Sponsor with certain personally identifiable information such as name, residential address, email address and/or other contact and/or tax information. Such information may be used for the purposes specifically described in these Event Rules.
- (c) The invalidity or unenforceability of any provision of these Event Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Event Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
- (d) All taxes, fees and surcharges on the Prize are the sole responsibility of the Prize winner. In the event that the selected winner of the Prize is ineligible or does not accept the Prize, the Prize will be forfeited and Sponsor, in its sole discretion, may choose to award the Prize to another participant in the Event.

## SPECIFIC EVENT RULES

### Part B

#### 1. Content of the Event

During this Event, all participants will be eligible to receive rewards in the form of USD10 Steam gift card.

#### 2. Prizes

The Sponsor shall provide each Event winner with a prize in the form of a USD10 Steam gift card (collectively, “**Prizes**”). If a winner resides in an area other than one of the countries listed in Section 2 (a) of Part A of these Rules, such a winner will instead receive Doubloons on their World of Warships account in the amount that can be purchased in their area’s Wargaming premium web shop for USD 10.

#### 3. Event Dates

The Event will start on **20 August 2024, 08:00 (UTC+8)**, and end on **31 August 2024, 15:59 (UTC+8)**. Event results will be determined, and prizes will be awarded not later than **30 September 2024, 23:59 (UTC+8)**.

#### 4. How to participate

Those persons who meet all the following criteria can participate in this Event:

- The person has a Wargaming account (has a WargamingID) and has played a total of at least one (1) battle in the Game using this account;
- The person has accepted the End User License Agreement of the Game and meets all its requirements for end users of the Game;
- The person has redeemed the Free DLC: World of Warships —Rental Agincourt (3 days) and purchased any Blue Archive bundle (Tier VIII Tirpiz Bundle, Tier IX Takahashi Bundle, Tier X Montana Bundles).

Five hundred (500) winners of the Event will be randomly selected out of all the eligible Event participants.

#### 5. How to receive the Prizes

To provide Prizes in the form of Steam gift cards, Sponsor will not later than **30 September 2024, 23:59 (UTC+8)** contact winners via the emails linked to their Wargaming accounts. Sponsor will give to winners the Steam friend code, which will enable them to become friends with the official World of Warships account on Steam. Three days after becoming friends on Steam the Sponsor will send the Prize in the form of a Steam gift card to each winner’s account. If the email is not valid, the Sponsor has a right to not provide the Prize.

Sponsor will provide Prizes in the form of Doubloons by sending the equivalent value of Doubloons via their World of Warships account. Prizes will be sent not later than **30 September 2024, 23:59 (UTC+8)**.

Players will need to go to their email accounts to check if they have received their prize. Spam folders of their email accounts may also need to be checked.
